**Celebrate the Holidays with Crafts**

At the Leesburg and One Loudoun Winter Farmers Markets!

Local Craft Vendors are invited to participate in the LVHMC Leesburg and One Loudoun Winter Farmers Markets “Celebrate the Holidays!” section for the 2017 Christmas Holiday Season which will run from the Grand Opening on November 4 through December 30, 2016, from 9am until Noon. The fee for this 9 week period is \$200 or individual Saturdays are \$25 per day. Preference will be given to Loudoun County artisans and to those who sign up for the entire 9 week period. The Markets will be advertised locally, and our email newsletter is sent weekly to over 4800 subscribers. You may choose between our Leesburg or One Loudoun locations.

The Market is outdoors and runs rain, snow or shine—it has a dedicated following that shops no matter what the weather. Generally, we can be flexible and allow the vendor to switch days in the event of extreme weather; however that will depend on available space.

The vendor will need to provide their own tent (if desired) that is weighted with at least 24 lbs per leg for safety. The vendor will also need to provide tables, chairs and other items to display and sell their goods. The vendor is responsible for collecting and paying all applicable sales tax according to VA state laws and must also submit proof of business liability insurance in effect in which LVHMC must be named on the policy as an “additional insured”. This proof of insurance must be presented before set up or the vendor will not be allowed to participate and will forfeit any fees.
